Mode	:	Fully virtual meeting to be conducted entirely through an online meeting platform (https://tiih.online) provided by our Share Registrar, Tricor Investor & Issuing House Services Sdn Bhd (“Tricor”)

MODE OF MEETING

1. The Company will conduct its 43rd AGM on a fully virtual basis through the online meeting platform provided by Tricor at <https://tiih.online>.

REMOTE PARTICIPATION AND VOTING (“RPV”)

2. Shareholders are to attend (including posing questions to the Board via real time submission of typed texts) and vote (collectively, “participate”) remotely at the 43rd AGM using Remote Participation and Voting Facilities (“RPV”) provided by Tricor via its TIIH Online website at <https://tiih.online>.
3. Shareholders who appoint proxies to participate via RPV in the 43rd AGM must ensure that the duly executed proxy forms are deposited at the office of Tricor, at Unit 32-01, Level 32, Tower A, Vertical Business Suite, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur or its Customer Service Counter at Unit G-3, Ground Floor, Vertical Podium, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur, no later than 3.00 p.m. on Tuesday, 28 May 2024. You may also submit the proxy appointment electronically via Tricor’s TIIH Online website at <https://tiih.online> no later than 3.00 p.m. on Tuesday, 28 May 2024. For further information on the electronic submission of Form of Proxy, kindly refer to item no. 10 below.
4. A shareholder who has appointed a proxy or attorney or corporate representative to participate at the 43rd AGM must request his/her proxy or attorney or corporate representative to register himself/herself for RPV via TIIH Online website at <https://tiih.online>.
5. As the 43rd AGM is a fully virtual meeting, shareholders who are unable to participate in this meeting may appoint the Chairman of the meeting as his/her proxy and indicate the voting instructions in the proxy form.

PROCEDURES FOR RPV

6. Shareholders/proxies/corporate representatives/attorneys who wish to participate in the 43rd AGM remotely using the RPV are to follow the requirements and procedures as summarised below:

Procedures		Action
BEFORE THE DAY OF THE AGM		
(a)	Register as a user with TIIH Online	<ul style="list-style-type: none"> Using your computer, access the website at https://tiih.online. Register as a user under the “e-Services”, select the “Sign Up” button and followed by “Create Account by Individual Holder”. Refer to the tutorial guide posted on the homepage for assistance. Registration as a user will be approved within one (1) working day and you will be notified via e-mail. If you are already a user with TIIH Online, you are not required to register again. You will receive an e-mail to notify you that the remote participation is available for registration at TIIH Online.
(b)	Submit your request	<ul style="list-style-type: none"> Registration is open now until the day of 43rd AGM on Thursday, 30 May 2024. Shareholders or proxies or corporate representatives or attorneys are required to pre-register their attendance for the 43rd AGM to ascertain their eligibility to participate at the 43rd AGM using the RPV facilities. Login in with your user ID and password and select the corporate event: “(REGISTRATION) OLYMPIA 43RD AGM”. Read and agree to the Terms & Conditions and confirm the Declaration. Select “Register for Remote Participation and Voting”. Review your registration and proceed to register. System will send an email to notify that your registration for remote participation is received and will be verified. After verification of your registration against the General Meeting ROD as at 23 May 2024, the system will send you an email on or after 28 May 2024 to approve or reject your registration for remote participation. <p><i>(Note: Please allow sufficient time for approval of new user of TIIH Online and registration for the RPV).</i></p>

(c)	Login to TIIH Online	<ul style="list-style-type: none"> Login with your user ID and password at https://tiih.online for remote participation at the 43rd AGM at any time from 2.00 p.m. i.e. 1 hour before the commencement of 43rd AGM on Thursday, 30 May 2024 at 3.00 p.m.
(d)	Participate through Live Streaming	<ul style="list-style-type: none"> Select the corporate event: “(LIVE STREAM MEETING) OLYMPIA 43RD AGM” to engage in the proceedings of the 43rd AGM remotely. If you have any questions for the Chairman/Board, you may use the query box to transmit your question. The Chairman/Board will endeavor to respond to questions submitted by remote participants during the 43rd AGM. If there is time constraint, the responses will be e-mailed to you at the earliest possible, after the meeting.

(e)	Online remote voting	<ul style="list-style-type: none"> • Voting session commences from 3.00 p.m. on Thursday, 30 May 2024 until a time when the Chairman announces the completion of the voting session of the 43rd AGM. • Select the corporate event: “(REMOTE VOTING) OLYMPIA 43RD AGM” or (if you are on the live stream meeting webpage) you may select the button “GO TO REMOTE VOTING PAGE” below the query box. • Read and agree to the Terms & Conditions and confirm the Declaration. • Select the CDS account that represents your shareholdings. • Indicate your votes for the resolutions that are tabled for voting. • Confirm and submit your votes.
(f)	End of remote participation	<ul style="list-style-type: none"> • Upon the announcement by the Chairman on the closure of the 43rd AGM, the Live Streaming will end.

Notes to users of the RPV facilities:

- (i) Should your registration for RPV be approved, we will make available to you the rights to join the live streamed meeting and to vote remotely. Your login to TIIH Online on the day of the 43rd AGM will indicate your presence at the virtual meeting.
- (ii) The quality of your connection to the live broadcast is dependent on the bandwidth and stability of the internet connection at your location and the device you use.

PROXY

7. The 43rd AGM will be a fully virtual meeting and if you are unable to attend the meeting via RPV on 30 May 2024, you may appoint the Chairman of the meeting as proxy and indicate the voting instructions in the Form of Proxy.
8. You may submit your proxy form to Tricor at Unit 32-01, Level 32, Tower A, Vertical Business Suite, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur or its Customer Service Counter at Unit G-3, Ground Floor, Vertical Podium, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur, not less than forty-eight (48) hours before the time appointed for holding the 43rd AGM or any adjournment thereof, otherwise the proxy form shall not be treated as valid.
9. You may also submit the proxy form electronically via TIIH Online website at <https://tiih.online> no later than 3.00 p.m. on Tuesday, 28 May 2024. Please do read and follow the procedures below to submit proxy form electronically.

ELECTRONIC LODGEMENT OF PROXY FORM

10. The procedures to lodge your proxy form electronically via Tricor’s TIIH Online website are summarised below:

Register as a User with TIIH Online	<ul style="list-style-type: none"> • Using your computer, please access the website at https://tiih.online. Register as a user under the “e-Services”. • Please do refer to the tutorial guide posted on the homepage for assistance. • If you are already a user with TIIH Online, you are not required to register again.

Proceed with submission of Form of Proxy	<ul style="list-style-type: none"> • After the release of the Notice of 43rd AGM by the Company, login with your user name (i.e. email address) and password. • Select the corporate event “OLYMPIA 43RD AGM – SUBMISSION OF PROXY FORM” • Read and agree to the Terms and Conditions and confirm the Declaration. • Insert your CDS account number and indicate the number of shares for your proxy(ies) to vote on your behalf. • Appoint your proxy(ies) and insert the required details of your proxy(ies) or appoint Chairman as your proxy. • Indicate your voting instructions – FOR or AGAINST, otherwise your proxy will decide your vote. • Review and confirm your proxy(ies) appointment. • Print proxy form for your record.
(b) Steps for Corporation and Institutional Shareholders	
Register as a User with TIIH Online	<ul style="list-style-type: none"> • Access TIIH Online at https://tiih.online. • Under e-Services, the authorised or nominated representative of the corporation or institutional shareholder selects the “Sign Up” button and followed by “Create Account by Representative of Corporate Holder”. • Complete the registration form and upload the required documents. • Registration will be verified, and you will be notified by email within one (1) to two (2) working day(s). • Proceed to activate your account with the temporary password given in the email and re-set your own password. <p><i>(Note: The representative of a corporation or institutional shareholder must register as a user in accordance with the above steps before he/she can subscribe to this corporate holder electronic proxy submission. Please contact our Share Registrar if you need clarifications on the user registration.)</i></p>
Proceed with submission of Form of Proxy	<ul style="list-style-type: none"> • Login to TIIH Online at https://tiih.online. • Select the corporate event name: “OLYMPIA 43RD AGM - SUBMISSION OF PROXY FORM”. • Agree to the Terms & Conditions and Declaration. • Proceed to download the file format for “Submission of Proxy Form” in accordance with the Guidance Note set therein. • Prepare the file for the appointment of proxies by inserting the required data. • Login to TIIH Online, select corporate event name: “OLYMPIA 43RD AGM - SUBMISSION OF PROXY FORM”. • Proceed to upload the duly completed proxy appointment file. • Select “Submit” to complete your submission. • Print the confirmation report of your submission for your record.

GENERAL MEETING RECORD OF DEPOSITORS (“ROD”)

11. Only members whose names appear on the ROD as at **23 May 2024** shall be entitled to attend the 43rd AGM or appoint proxies to attend and/or vote on his/her behalf via RPV.

POLL VOTING

12. The voting at the 43rd AGM will be conducted by poll in accordance with Paragraph 8.29A of Main Market Listing Requirements of Bursa Malaysia Securities Berhad. The Company has appointed Tricor as Poll Administrator to conduct the online polling.
13. Shareholders/proxies/corporate representatives/attorneys can proceed to vote on the resolutions at any time from the commencement of the 43rd AGM on Thursday, 30 May 2024 at 3.00 p.m. to the end of the voting session which will be announced by the Chairman of the meeting. Kindly refer to item (e) of the above Procedures for RPV for guidance on how to vote remotely from TIIH Online website at <https://tiih.online>.
14. Upon completion of the voting session for the 43rd AGM, the Scrutineers will verify the poll results followed by the Chairman's declaration whether the resolutions are duly passed.

PRE-MEETING SUBMISSION OF QUESTIONS TO THE BOARD OF DIRECTORS

15. Shareholders may submit questions for the Board in advance of the 43rd AGM via Tricor's TIIH Online website at <https://tiih.online> by selecting "e-Services" to login, pose questions and submit electronically no later than 3.00 p.m. on Tuesday, 28 May 2024.

NO DOOR GIFT VOUCHERS

16. There will be **no distribution** of door gift vouchers for the 43rd AGM.
